**RESOLUTION NO. 02-10-207**

**EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF TEN MILLION PESOS (PHP10M) TO BE USED FOR THE CONSTRUCTION OF A FEEDER PORT AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS,** it has been an arduous desire of the Municipal Government of Bulalacao, Oriental Mindoro to improve its temporary landing center which is the river bank of the Kaburayan River at the town proper through the construction of a permanent and good feeder port to serve the incoming and outgoing cargo, passenger and fishing boats;

**“WHEREAS,** being situated at the southernmost tip of the Province of Oriental Mindoro, the Municipality of Bulalacao needs various infrastructural facilities which would hasten social and economic development;

**“WHEREAS,** the construction of feeder port at this Municipality would encourage more investments, enhance trade and commerce with other municipalities, promote employment and generate additional revenue for the municipal government necessary to finance various developmental projects beneficial to its people;

**“WHEREAS,** the cherished dream of having a feeder port is believed to be realized only through the assistance of President Arroyo for it supports her priority programs that of countryside development; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED;** To: Earnestly request Her Excellency Gloria Macapagal Arroyo, President, Republic of the Philippines to allocate the amount of Ten Million Pesos (Php10M) to be used for the construction of a feeder port at the Municipality of Bulalacao, Province of Oriental Mindoro;
