“WHEREAS, the present ambulance of the Bulalacao Community Hospital is badly damaged that a necessary repair is needed to make it safe and serviceable; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Thaddeus Venturanza, Provincial Vice Governor and Presiding Officer of the Sangguniang Panlalawigan to allocate the amount of Sixty Thousand Pesos (PhP60,000.00) to be used for the repair of ambulance at the Bulalacao Community Hospital, Bulalacao, this Province;
