"WHEREAS, because of poverty and lack of education they are commonly found to be at the lowest ladder of socio-economic strata;


"WHEREAS, there is a need for them to have an Office or just a simple hall wherein they ventilate, synthesize and crystallize their ideas, so as to promote their common weal;


"WHEREAS, the Hanunuo-Mangyans of Bulalacao dream of having a Bahay Pulungan; Now, therefore, be it


