OPPOSING HOUSE BILL NO. 4110 "REPRODUCTIVE HEALTH CARE AGENDA" IN ITS STRONGEST SENSE AS IT GO AGAINST THE PROVISION OF A CONSTITUTIONAL MANDATE ABOUT FAMILY AND FAMILY LIFE

"WHEREAS, under Section 12 of Article II, as a policy, the State recognizes the sanctity of family life and shall protect and strengthen the family as a basic autonomous social constitution. It shall equally protect the life of the mother and the life of the unborn child from contraception. The natural and primary right and duty of the parents in the rearing of the youth for civic efficiency and the development and moral character shall receive the support of the government;

"WHEREAS, certain provisions of House Bill No. 4110 "Reproductive Health Care Agenda" contradict the abovementioned Constitutional State Policy and therefore must be opposed by every Filipino whose moral strength and fiber might be damaged if such bill be passed into law; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Oppose House Bill No. 4110 "Reproductive Health Care Agenda in its strongest sense as it go against the provision of a Constitutional mandate about family and family life;
