EARNESTLY REQUESTING MR. PETRONILO B. BUENDIA, GENERAL MANAGER, PHILIPPINE FISHERIES DEVELOPMENT AUTHORITY (PFDA) TO ALLOCATE THE NECESSARY FUNDS FOR THE CONSTRUCTION OF A FISHING PORT AT BARANGAY POBLACION, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 is devoid of various infrastructural facilities needed to boost the social and economic status of the town and its people;

"WHEREAS, Bulalacao is popularly noted for its high production of marine products such as fish, crabs, shrimps, lobster, et cetera which are being transported to Malabon, Cavite and Manila that it is very important to provide these fishermen with the necessary infrastructural facility to improve production and income;

"WHEREAS, it is believed that the construction of support facility such as that of fish port will provide the fisherfolks greater access to modern technologies that shall improve the handling, storage, processing and distribution of fishery products;
