RESOLUTION EXPRESSING THE INTENTION OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO PURCHASE THE LAND BEING OFFERED TO SELL BY EDUARDO C. ACERON TO BE USED AS ACCESS ROAD FROM THE PROVINCIAL ROAD GOING TO BULALACAO PUBLIC MARKET

"WHEREAS, in order to lighten the flow of traffic at Barangay Campaasan, the Municipal Government of Bulalacao initiated the construction of access road from the Provincial Road going to the public market for the safety of both the vehicles and pedestrians alike;

"WHEREAS, such access road utilized the lot owned by Eduardo C. Aceron with an area of 120 square meters which he voluntarily offered to the Municipal Government in the amount of Five Hundred Pesos per square meter (Php500.00 sq. m.) a total of Sixty Thousand Pesos (Php60,000.00)


"WHEREAS, to facilitate payment of the abovementioned lot, this resolution is passed along with various related documents; Now, therefore, be it
