EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL-ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES THROUGH SECRETARY ARTURO YAP, PRESIDENTIAL MANAGEMENT STAFF CHIEF TO INCLUDE AND PRIORITIZE THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE GRANT OF TULAY NG PANGULO PARA SA MAGSASAKA PROGRAM

“WHEREAS, it is the thrust of the present Administration to extend further the effective and efficient delivery of basic social services to its constituents that all possible resources are being tapped for the implementation of various infrastructural projects particularly the construction of farm to market roads and bridges;

“WHEREAS, a passable and an all-weather farm to market roads in addition to a permanently built bridges would facilitate the movements of people and shipment of agricultural and marine products necessary for the upliftment of the social and economic status of the community and its people;

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro in spite of limited funds is prioritizing the construction and rehabilitation of farm to market roads for it believes that rural infrastructure is needed to jumpstart local economy which would be more realistic if it be coupled with the construction of bridges;

"WHEREAS, the following bridges mentioned herein are located within the Agrarian Reform Communities that there is a dire need to construct them permanently to best serve its objective of providing enough opportunities for marginal farmers achieve social and economic growth, to wit:

- i. Bagong Sikat Bridge - Barangay Bagong Sikat
- ii. Bancal Bridge - Barangay San Juan
- iii. Talibong Bridge - Barangay San Juan
- iv. Barombong Bridge - Barangay Nasucob
- v. Maujao Bridge - Barangay Maujao
