"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

"WHEREAS, Bulalacao is a 3rd class municipality with a vast agricultural land, has 15 barangays and with a total agricultural land area of 10, 325.80 hectares where 6,016 individuals are employed in the agricultural sector;

"WHEREAS, the Municipality of Bulalacao is composed of eight (8) coastal barangays whose main source of living comes from aquaculture activities with its hydrographic conditions favoring high production such as fishing;

"WHEREAS, Bulalacao declared state of calamity on February 26, 2024 due to the severe impacts of el niño which resulted to the damaged of 539.1 ha of rice, 850 ha of onion, 985 ha of other high value crops involving a total of 4,200 farmers with agricultural losses amounting to Php 352,107,506.00;


"WHEREAS, on March 06, 2023, the Sangguniang Panlalawigan of Oriental Mindoro approved the resolution declaring the State of Calamity due to oil spill in the 77 coastal barangays from 9 municipalities of the province namely Naujan, Pola, Pinamalayan, Gloria, Bansud, Bongabong, Roxas, Mansalay and Bulalacao;
