EARNESTLY REQUESTING THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) THRU ITS CHAIRMAN AND CHIEF EXECUTIVE, EPHRAIM C. GENUINO TO GRANT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH FIVE MILLION PESOS (PHP5M) WORTH OF MEDICAL AND RESCUE FIRST AID KIT TO BE USED BY THE PATIENTS IN CASE OF EMERGENCIES

“WHEREAS, it is a Constitutional mandate that the State shall protect and promote the right to health of the people and instill health consciousness among them;

“WHEREAS, the Municipality of Bulalacao is located in the southernmost tip of the Province of Oriental Mindoro is composed of a population of 20% Hanunuo Mangyans who do not have access to proper medical treatment and affordable medicines;

“WHEREAS, sufficient supply of medicines added to the availability of medical apparatus and equipments, the Rescue and First Aid Kit most specially are direly needed in an effort to maintain good health, prevention and control of diseases and in saving lives in serious cases where matter between life and death is concern;

"WHEREAS, hounded with financial constraints being the Pro-Poor Municipality, the abovementioned request is believed to be realized only thru the assistance of the higher and service oriented agency such as that of a PAGCOR; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Philippine Amusement and Gaming Corporation (PAGCOR) thru its Chairman and Chief Executive, Ephraim C. Genuino to grant the Municipality of Bulalacao, Province of Oriental Mindoro with Five Million Pesos (Php5M) worth of medical and Rescue First Aid Kit to be used by the patients in cases of emergencies;
