
"WHEREAS, pursuant to the Joint Administrative Order No. 02-92 also known as Rules and Procedures Governing the Distribution of Cancelled or Expired Pasture Lease Agreements (PLAS) and Timber License Agreements (TLAS), states that "This order shall apply only to the redistribution or reallocation of lands of the public domain covered by cancelled or expired Pasture Lease Agreements (PLAs) and Timber License Agreements (TLAs) identified by the Department of Environment and Natural Resources (DENR) in favor of Agrarian Reform Beneficiaries (ARBs) either individually or collectively duly screened and verified by the Department of Agrarian Reform (DAR);


"WHEREAS, the Local Government Unit of Bulalacao supports the request of Philippine Army to DENR in assessing the expired pasture lease agreement situated in Barangay Benli for the purpose of using it as their training ground and strengthen peace and security in this municipality; Now, therefore, be it...




