EARNESTLY REQUESTING THE PROVINCIAL GOVERNMENT OF THE PROVINCE OF ORIENTAL MINDORO TO PROVIDE LIVELIHOOD AND TECHNICAL ASSISTANCE TO THE AFFECTED "ULING" MANUFACTURERS OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN VIEW OF THE STRICT IMPLEMENTATION AND REGULATION IMPOSED AGAINST SHIPMENT OF THE SAID PRODUCTS OUT OF THIS PROVINCE

"WHEREAS, significant percentage of Bulalacao's populace more particularly those living in the hinterlands primarily the hanunuo mangyans relies on their livelihood on charcoal making or "pag-uuling" to sustain their daily existence;

"WHEREAS, this kind of occupation has been proved to be inimical to our environment; thus the Provincial Government has discouraged this practice and prohibited the shipment of the same to other provinces;

"WHEREAS, this regulation affects the abovesited sector of our society having been dislocated or displaced from their usual source of living hence, the need for an alternative livelihood program; Now, therefore, be it


