RESOLUTION NO. 05-02-027-A

AUTHORIZING THE MUNICIPAL MAYOR TO APPLY AND ENTER INTO A LOAN AGREEMENT WITH LAND BANK OF THE PHILIPPINES, ROXAS BRANCH TO AVAIL AN AMOUNT OF SEVEN MILLION PESOS (PHP7M) FOR THE PURCHASE OF HEAVY EQUIPMENTS TO BE USED FOR THE VARIOUS INFRASTRUCTURAL PROJECTS OF THIS MUNICIPALITY

"WHEREAS, the Municipal Government of Bulalacao intends to fast track the construction and completion of various infrastructure projects included in its Annual Investment Plan (AIP) for the next three (3) years in order to propel the economy of the town;

"WHEREAS, the Municipal Mayor requested this Body and which was secondly approved to acquire the following heavy equipments; to wit:

i.	Dumptruck	-	4 units
ii.	Grader	-	1 unit
iii.	Back hoe	-	1 unit
iv.	Roadroller compactor	-	1 unit
v.	Bulldozer	-	1 unit
