RESOLUTION REQUESTING THE HONORABLE REYNALDO V. UMALI, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO FAVORABLY INDORSE RESOLUTION NO. 11-03-059, REQUESTING THE HONORABLE PROCESO J. ALCALA, SECRETARY, DEPARTMENT OF AGRICULTURE TO ALLOCATE THE AMOUNT OF TWENTY MILLION PESOS (PHP20M) TO BE USED FOR THE CONSTRUCTION OF FARM TO MARKET ROAD FROM SITIO IMBUYUNGAN-SITIO KALONG, BARANGAY NASUCOB TO SITIO BASAKAR, BARANGAY BALATASAN, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 1, Article XII of the Constitution provides that the goals of the national economy are more equitable distribution of opportunities, income and wealth, a sustainable increase in the amount of goods and services produced by the Nation for the benefit of the people and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged;


