"WHEREAS, the Municipality of Bulalacao which is situated in the southernmost tip of the Province of Oriental Mindoro suffers a lot of inconvenience and difficulties in going to the capital City of Calapan due to poor road conditions;

"WHEREAS, the road from Barangay Nasucob going to Cavillan to Tambangan is part of Bulalacao to Mansalay National Road still remains to be rugged and muddy especially during rainy season which hinders the upliftment of the social and economic status of the community and its people;

"WHEREAS, this poor road condition likewise hampers the development of the eleven (11) Tourist Spot Reserves declared pursuant to Executive Order No. 370;


