RESOLUTION NO. 06-01-008

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2006 OF BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF SEVEN HUNDRED THIRTY THREE THOUSAND PESOS (Php 733,000.00) PASSED UNDER RESOLUTION NO. 45-05 DATED OCTOBER 1, 2005

"WHEREAS, Section 57 and Section 447 par (II) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of Campaasan, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY2006 showing therein the sources of income and barangay expenditures starting from January 1, 2006 up to December 31, 2006;


"WHEREAS, the Barangay Fund Annual Budget for FY2005 of Barangay Campaasan was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on January 23, 2006 and was found to be consistent and in accordance with the priority development projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;
