REQUESTING THE SECRETARY, DEPARTMENT OF LABOR AND
EMPLOYMENT (DOLE) THRU MIMAROPA REGIONAL DIRECTOR ZENAIDA
E. ANGARA TO ALLOCATE AT LEAST FIFTEEN (15) NEGO-CART AND AT
LEAST TEN (10) IT SLOTS FOR THIS YEAR TO THE MUNICIPALITY OF
BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, poverty remains the most vital developmental problem of the
country as reflected in the Municipality of Bulalacao where majority of the people
are unable to meet the standards of quality of life;

"WHEREAS, such poverty can be generally blamed to unemployment
opportunities in the formal market hence the need to enhance the poor's
productive assets by facilitating access to financial services;

"WHEREAS, since most of our poor engage in multiple micro or livelihood
enterprises which are relatively easy to start and manage and have a ready
market in the immediate community;

"WHEREAS, the grant of financial assistance through the NEGO-CART
Project by the Department of Labor and Employment shall give the poor access
to micro-business activities as a form of an economic stimulus aimed at reducing
incidence of poverty in the grass-root level;

"WHEREAS, it shall be imperative that the government provide economic
assistance to families living under the poverty threshold by making them
responsible partners in strengthening the so-called underground economy;

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Secretary, Department of Labor and Employment (DOLE) thru MIMAROPA-Regional Director Zenaida E. Angara to allocate at least fifteen (15) Nego-Cart and at least ten (10) IT slots for this year to the Municipality of Bulalacao, Province of Oriental Mindoro;


