### RESOLUTION NO. 11-02-045

REQUESTING THE HONORABLE CORAZON "DINKY" J. SOLIMAN, SECRETARY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT THROUGH REGIONAL DIRECTOR VIOLETA A. CRUZ TO GRANT AT LEAST TEN MILLION PESOS (PHP10M) FOR THE LIVELIHOOD PROJECT UNDER THE SELF EMPLOYMENT ASSISTANCE-KAUNLARAN (SEA-K) PROGRAM FOR THE BENEFIT OF THE MARGINALIZED SECTOR OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, poverty remains the most vital developmental problem of the country as reflected in the Municipality of Bulalacao where majority of the people are unable to meet the standards of quality of life;

"WHEREAS, such poverty can be generally blamed to unemployment opportunities in the formal market hence the need to enhance the poor's productive assets by facilitating access to financial services;

"WHEREAS, since most of our poor engage in multiple micro or livelihood enterprises which are relatively easy to start and manage and have a ready market in the immediate community;

"WHEREAS, the grant of financial assistance through the SEA-K Program shall give the poor access to micro-business activities as a form of an economic stimulus aimed at reducing incidence of poverty in the grass-root level

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Honorable Corazon "Dinky" J. Soliman, Secretary, Department of Social Welfare and Development through Regional Director Violeta A. Cruz to grant at least Ten Million Pesos (Php10M) for the livelihood project under the Self Employment Assistance-Kaunlaran (SEA-K) Program for the benefit of the marginalized sector of Bulalacao, Oriental Mindoro;


