RESOLUTION NO. 11-02-038

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2011 OF BARANGAY BENLI, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF ONE MILLION SIX HUNDRED SEVENTY THOUSAND EIGHT HUNDRED SEVENTY TWO PESOS AND THIRTEEN CENTAVOS (PHP1,670,872.13) PASSED UNDER SANGGUNIANG APPROPRIATION ORDINANCE NO. 01

“WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Sangguniang Barangay of Benli, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2011 showing therein the sources of income and barangay expenditures starting from January 1, 2011 up to December 31, 2011;

“WHEREAS, the Barangay Fund Annual Budget for FY 2011 of Barangay Benli was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 28, 2011 and was found to be consistent and in accordance with the priority developments projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;

"WHEREAS, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations, Now, therefore, be it;

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 2011 of Barangay Benli, Bulalacao, Oriental Mindoro, appropriating the amount of One Million Six Hundred Seventy Thousand Eight Hundred Seventy Two Pesos and Thirteen Centavos (Php1,670,872.13) passed under Sangguniang Barangay Appropriation Ordinance No. 01;




