## RESOLUTION NO. 09-09-112

EARNESTLY REQUESTING THE HONORABLE MAR A. ROXAS, SENATOR,  
REPUBLIC OF THE PHILIPPINES TO ALLOCATE TEN (10) SLOTS OF  
TESDA SCHOLARS FOR THE MUNICIPALITY OF BULALACAO, PROVINCE  
OF ORIENTAL MINDORO

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro is a Pro-Poor Municipality pursuant to Executive Order No. 370 and whose population is composed of approximately twenty percent Hanunuo-Mangyans who could hardly cope-up with their basic needs;

“WHEREAS, it is sad to note that one half of the graduates of the Bulalacao National High School could not continue to acquire a four-year college education due to poverty that the present Administration should provide for another alternative to help these students earn at least a vocational course under the Technical Education and Skills Development Authority (TESDA) through Scholarship Grants;

“WHEREAS, information had reached to this Sanggunian that every Senator has an allocation of certain number of TESDA scholars to which it shall be highly valued and appreciated if the ten (10) slots of which shall be allocated for the Municipality of Bulalacao, Oriental Mindoro;

“WHEREAS, the allocation of ten (10) slots of TESDA scholars for this Municipality would definitely give enough opportunity for our students and out-of-school youth to acquire vocational courses which are presently in-demand for local and foreign employment, thus uplifting their social and economic condition and of the community as a whole; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request the Honorable Mar A. Roxas, Senator, Republic of the Philippines to allocate ten (10) slots of TESDA scholars for the Municipality of Bulalacao Province of Oriental Mindoro.






