### RESOLUTION NO. 09-09-108

EARNESTLY REQUESTING THE HONORABLE JUAN MIGUEL F. ZUBIRI, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF PHP2,000,000.00 (PHP2MILLION) TO BE USED FOR THE PAYMENT OF SALARIES OF LOCALLY-FUNDED TEACHERS IN THE SCHOOL DISTRICT OF BULALACAO, THIS PROVINCE

“WHEREAS, education is one of the primordial priorities of this present administration;

“WHEREAS, even the Constitution provides that the largest portion of the budgetary pie shall be allocated for education in order that it shall be accessible, of good quality and available to every Filipino;

“WHEREAS, in pursuing this mandate, the Local Government Unit of Bulalacao, Oriental Mindoro hired the services of at least 100 teachers, as the DepEd's fund was not enough to sustain the growing number of children who are of school ages in this Municipality;

“WHEREAS, the salaries and wages of these so-called locally hired teachers come from the already limited fund of the municipal government;

“WHEREAS, the municipal government is apprehensive that severe financial repercussions are not too far considering its dwindling monetary capacity to foot the salaries and wages of those teachers taking into account that it is only mid-way for SY 2009-2010;

"WHEREAS, each teacher receives Php4,000.00 per month as salary/wages for a month of work; and it is imperative that their services be continued so as not to leave the education of enrollees hanging in a balance with dire consequences if not properly addressed;

"WHEREAS, this Sanggunian sees hope in the benevolence of Senator Juan Miguel F. Zubiri to help resolve this particular problem where this Municipality faces an abyss of financial difficulty; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Juan Miguel F. Zubiri, Senator, Republic of the Philippines to allocate the amount of Php2,000,000.00 (Php2Million) to be used for the payment of salaries of locally-funded teachers in the School District of Bulalacao, this Province;
