**"WHEREAS**, Section 35 of the same law further provides that local government units may enter into a joint ventures and such other cooperative arrangements with peoples nongovernmental organizations to engage in the delivery of certain basic services, capability building and livelihood projects and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance and enhance the economic and social well-being of the people;




