### RESOLUTION NO. 09-06-086

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2009 OF  
BARANGAY MILAGROSA, BULALACAO, ORIENTAL MINDORO  
APPROPRIATING THE AMOUNT OF EIGHT HUNDRED NINETY THREE  
THOUSAND TWO HUNDRED TEN PESOS AND EIGHTY TWO CENTAVOS  
(PHP893,210.82) PASSED UNDER SANGGUNIANG BARANGAY  
APPROPRIATION ORDINANCE NO. 01-2009 DATED NOVEMBER 6, 2008

“WHEREAS, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

“WHEREAS, the Barangay Fund Annual Budget for FY 2009 of Barangay Milagrosa was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on June 22, 2009 and was found to be consistent and in accordance with the priority developments projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects


