### RESOLUTION NO. 09-04-061

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 2009 OF BARANGAY BALATASAN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF ONE MILLION TWELVE THOUSAND TWO HUNDRED EIGHTY ONE PESOS AND SIXTY SIX CENTAVOS (PHP1,012,281.66) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 01-T-09 DATED JANUARY 5, 2009

**"WHEREAS**, Section 57 and Section 447 par (li) empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

**"WHEREAS**, the Sangguniang Barangay of Balatasan, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 2009 showing therein the sources of income and barangay expenditures starting from January 1, 2009 up to December 31, 2009;

**"WHEREAS**, the Barangay Fund Annual Budget for FY 2009 of Barangay Balatasan was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on April 27, 2009 and was found to be consistent and in accordance with the priority developments projects of the barangay with the advice that all projects funded under the 20% Development Fund be implemented and should not be realigned to any other projects;

**"WHEREAS**, it is therefore understood that disbursement of appropriation shall be guided by existing COA rules and regulations. Now, therefore, be it;

**RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 2009 of Barangay Balatasan, Bulalacao, Oriental Mindoro, appropriating the amount of One Million Twelve Thousand Two Hundred Eighty One Pesos and Sixty Six Centavos (Php1,012,281.66) passed under Sangguniang Barangay Appropriation Ordinance No. 01-T-09 dated January 5, 2009;**


