RESOLUTION APPROVING THE ACQUISITION OF 1-UNIT BRAND NEW PICK-UP VEHICLE AND 1-UNIT EXCAVATOR/BACKHOE TO BE USED EXCLUSIVELY BY THE MUNICIPAL DISASTER RISK REDUCTION OFFICE FOR ITS IMMEDIATE ASSISTANCE AND RESCUE DURING THE ONSLAUGHT OF DISASTER AND FOR ITS CLEARING AND REHABILITATION ACTIVITIES

"WHEREAS, pursuant to the Local Government Code of 1991, the Local Government Unit are expected to be at the frontline of emergency measures in the aftermath of disasters to ensure the general welfare of its constituents;

"WHEREAS, every Local Government Unit should create a Local Disaster Risk Reduction and Management Plan (LDRRMP) covering four aspects of Disaster Risk Reduction Management such as disaster preparedness, response, prevention and mitigation and rehabilitation and recovery;

"WHEREAS, the Municipal Disaster Risk Reduction Management Council had identified and submitted to this Sanggunian various programs and projects to support pre-disaster preparedness programs and post-disaster activities to which the availability of service vehicles such as Pick-up Vehicle and Backhoe are direly needed; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the acquisition of 1-unit brand new Pick-up Vehicle and 1-unit Excavator/Backhoe to be used exclusively by the Municipal Disaster Risk Reduction Office for its immediate assistance and rescue during the onslaught of disaster and for its clearing and rehabilitation activities;






