RESOLUTION REQUESTING THE PROVINCIAL GOVERNOR HUMERLITO "BONZ" A. DOLOR TO ALLOCATE FUNDS FOR THE OPENING AND CONCRETING OF ROADS CONNECTING BARANGAY BAGONG SIKAT TO MAUJAO TO BE DECLARED AS PROVINCIAL ROAD IN BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao is on its way to being an agro-eco-tourism destination in the Province of Oriental Mindoro that collaborative hard works from both government and private sectors are applied and gathered together to deliver the best positive outcome;

"WHEREAS, Bulalacao is a third class municipality located at the southernmost tip of Oriental Mindoro with a population of 44,366 based on 2020 census, 25 percent of which are indigenous people called Hanunuo Mangyan, it has a municipal government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;

"WHEREAS, the Local Government Unit of Bulalacao is focused and steadfast in improving the infrastructure projects and development programs of the municipality as a whole by prioritizing the completion of road constructions that are beneficial to its people;

"WHEREAS, the concreting of the connecting road of Barangay Bagong Sikat and Maujao would positively allow fast access to the transporting vehicles and provide convenience to its people which shall help and support in the progress and development of both barangays;
