RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 01 CY 2016 OF BARANGAY SAN ROQUE AMOUNTING TO TWO HUNDRED FIFTY TWO THOUSAND THREE HUNDRED THIRTY FOUR PESOS AND SEVENTY CENTAVOS (PHP252,334.70) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 2016-03 DATED DECEMBER 3, 2016

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve Supplemental Budget No. 01 CY 2016 of Barangay San Roque amounting to Two Hundred Fifty Two Thousand Three Hundred Thirty Four Pesos and Seventy Centavos (PhP252,334.70) passed under Sangguniang Barangay Appropriation Ordinance No. 2016-3 dated December 3, 2016 with the following recommendations, to wit:

1. That, the Improvement of School Building in Agong in the amount of PhP10,000.00 is disapproved for it is against COA Rules instead, it is recommended that should stay an unappropriated amount;
2. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
3. That, the disbursement of fund shall be in accordance with COA Rules and Regulations;
4. That, the Sangguniang Barangay of San Roque is likewise advise to strictly follow the recommendation of the Local Finance Committee as reflected in the review letter attached herewith;

- 5. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of San Roque in connection with the implementation of said appropriation ordinance.




