“WHEREAS, the Municipal Disaster Risk Reduction Management Council (MDRRMC) composed of various sectors and barangays officials convened on March 1, 2017 to identify, prioritize and formulate programs and projects to support disaster risk management activities such as pre-disaster preparedness and post-preparedness activities to ensure the safety of lives and properties during the occurrence of disaster either natural or man-made;

“WHEREAS, the Local Climate Change Action Plan (LCCAP) for Fiscal Year 2017-2022 of the Municipality of Bulalacao, Oriental Mindoro is anchored from the National Climate Change Action Plan (NCCAP) which was adopted in April 2010 which outlines the country’s agenda for adaptation and mitigation;

“WHEREAS, following the NCCAP, the municipality’s LCCAP is designed with the following work priorities and targeted outcomes:
