RESOLUTION NO. 19-12-248

EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS THRU SECRETARY MARK A. VILLAR TO GRANT AT LEAST TWO HUNDRED SEVENTY MILLION PESOS (PhP270M) FROM ITS QUICK RESPONSE FUND TO THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO BE USED FOR THE RESTORATION AND REHABILITATION OF INFRASTRUCTURAL FACILITIES LIKE ROADS AND BRIDGES WHICH WERE HEAVILY DAMAGED BY TYPHOON TISOY

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro suffered extreme and various losses in agricultural production, livestock and fishing industries caused by Typhoon Tisoy on December 3, 2019;

“WHEREAS, it was also noted that transportation and communication facilities were destroyed, houses and other building structures were damaged resulted to social and emotional sufferings of the affected families;

“WHEREAS, based on initial report submitted by the Municipal Engineering Office, the total damages in infrastructural facilities such as roads and bridges is estimated to be two hundred seventy million pesos (PhP270M) that there is a need to rehabilitate these facilities in order to restore the normal living conditions of the affected community from the deep stress and fear brought by Typhoon Tisoy;


“WHEREAS, along with the rehabilitation of infrastructural facilities equally important is the construction of footbridge at Sitio Luggis, Barangay Cambunang, Bulalacao, Oriental Mindoro that shall connect this sitio to Barangay Cambunang Proper where large volume of agricultural products need to traverse along this footbridge; **Now, therefore, be it**

RESOLVED AS IT IS HEREBY RESOLVED To: Earnestly request the Department of Public Works and Highways thru Secretary Mark A. Villar to grant at least Two Hundred Seventy Million Pesos (PhP270M) from its Quick Response Fund to the Municipality of Bulalacao, Province of Oriental Mindoro to be used for the restoration and rehabilitation of infrastructural facilities like roads and bridges which were heavily damaged by Typhoon Tisoy;


