RESOLUTION NO. 19-12-246

DECLARING THE ENTIRE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO UNDER THE STATE OF CALAMITY DUE TO DEVASTATION CAUSED BY TYPHOON TISOY

“WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro suffered damages and various losses in agriculture, livestock and fishing industries caused by Typhoon Tisoy which occurred on December 3, 2019 that brought distress, deep grief and misfortune among its inhabitants particularly the marginalized groups;

“WHEREAS, Typhoon Tisoy caused minor landslides in certain areas that made delay on several transportation facilities, such as roads and bridges, houses and other building structures were heavily damaged resulted to social and economic turmoil among the residents particularly the poor and the helpless families who were badly affected by this natural calamity;

“WHEREAS, the Local Government Unit of Bulalacao declared this Municipality under the State of Calamity because of the initial reports submitted by the Municipal Disaster Risk Reduction Management Office, the Municipal Social Welfare and Development Office, the Municipal Agriculture Office and the Municipal Engineering Office showing remarkable losses in agriculture, infrastructure and fisheries where thereafter the MDRRMC recommended for the declaration of the State of Calamity thru Resolution No. 01-12 s. 2019;


“WHEREAS, the disbursements of funds for rehabilitation purposes brought by Typhoon Tisoy shall be limited to the 30% of the 5% Calamity Fund, CY 2019 which is equivalent to PhP2,393,545.68;; **Now, therefore, be it**


RESOLVED AS IT IS HEREBY RESOLVED To: Declare the entire Municipality of Bulalacao, Oriental Mindoro under the State of Calamity due to devastation caused by Typhoon Tisoy;




