“**WHEREAS**, pursuant to Section 102 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, there shall be established a Local Health Board in every Municipality primarily task to ensure the effective and efficient delivery of basic health services;

“**WHEREAS**, Administrative Order No. 168, s. 2004 entitled “National Policy on Health Emergencies and Disasters provides that all health facilities should have an Emergency Preparedness and Response Plan now known as Disaster Risk Reduction Management for Health Plan (DRRM-H Plan) and a Health Emergency Management Program;

“**WHEREAS**, Executive Order No. 02-06, s. 2022 ordered the reorganization of the expanded Local Health Board in the Municipality of Bulalacao, Province of Oriental Mindoro;


“**WHEREAS**, the purpose of the Plan is to continue strengthening disaster risk reduction in order to prevent deaths, diseases, disabilities and the psychological impact of emergencies and disasters through people-centered actions and cross-cutting approaches. The Plan aims to improve the safety of integrated health services networks through the application of safe hospital criteria and approaches to climate change in the planning, design, construction and operation of such services;

"WHEREAS, with the institutionalization of the DRRM-H Plan in coordination with other stakeholders in the Municipality, every individual is assured of protection against the ill effects of disaster because of the formulation of various mitigating measures and quick response to emergencies and hazards; **Now, therefore, be it**
