**REQUESTING THE DEPARTMENT OF TRANSPORTATION THRU THE
LAND TRANSPORTATION OFFICE TO SUSPEND THE IMPLEMENTATION
OF PRIVATE MOTOR VEHICLE INSPECTION CENTER (PMVIC) IN
CALAPAN CITY, PROVINCE OF ORIENTAL MINDORO**

“WHEREAS, pursuant to the authority vested by the Department of Transportation to the Land Transportation Office to issue guidelines relative to the authorization of Private Motor Vehicle Inspection Centers (PMVIC) and under LTO Memorandum Circular No. 2018-2158 entitled “Guidelines for the authorization of Private Motor Vehicle Inspection Centers, it is directed that all PMVICs granted with authorization shall commence operations effective October 16, 2020;

“WHEREAS, in respect to the noble objectives of the DOTr in authorizing the operation of PMVICs in the proper registration of private motor vehicles in identified areas, this is a fervent humble request of the people of the Province of Oriental Mindoro particularly the residents of the Municipality of Bulalacao to suspend its operation and instead authorize the operation of PMVIC in Pinamalayan, Oriental Mindoro as done before;

“WHEREAS, the Municipality of Bulalacao is situated in the southernmost tip of the Province of Oriental Mindoro where travel time will take about 4 to 5 hours that motor vehicle owner take a lot of time and expenses in going to Calapan City, the only PMVIC in the province;

“WHEREAS, during this time of pandemic where covid-19 still remains to threaten every citizen and wherein health protocols is strictly implemented and where everybody is advised to stay at home if possible, the operation of PMVIC in Calapan City seems to be unreasonable and untimely; **Now, therefore, be it**






