RESOLUTION NO. 20-06-276

RESOLUTION ON THE CONSOLIDATED ACTIONS BY THE SANGGUNIANG BAYAN RELATING TO THE REVIEW OF LEGISLATIVE MEASURES BY VARIOUS BARANGAYS, AS RECOMMENDED BY THE COMMITTEE ON FINANCE, BUDGET AND APPROPRIATION DURING THE REGULAR SESSION ON JUNE 1, 2020

"WHEREAS, Section 57 and Section 447 par (li) of RA No. 7160 empower the Sangguniang Bayan to review all ordinances passed by the Sangguniang Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, in accordance with the abovementioned mandate, various barangays submitted their Annual Budget for FY 2020 showing therein the estimated sources of income and expenditures starting from January 1, 2020 up to December 31, 2020 to this Sanggunian for review, Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED BY THE SANGGUNIANG BAYAN OF BULALACAO, that:

SECTION 1. Action Taken by the Sangguniang Bayan. Considering the review of the Committee on Finance, Budget and Appropriation based on findings and recommendations of the Local Finance Committee, the Sangguniang Bayan resolves to take the following actions on the legislative measures of various barangays in the Municipality of Bulalacao:

1.1 Barangay Poblacion

SECTION 2. Conditions. The review actions of the Sanguniang Bayan under Section 1 are subject to the following mandatory conditions:

2.1. That, full compliance with all applicable laws, rules and regulations shall be the primary and continuing responsibility of the concerned officials and employees of the concerned Sangguniang Barangay in the implementation of their respective ordinances as stated in Section 1.

2.2 That, respective Sangguniang Barangays are likewise advised to strictly follow the recommendations of the Local Finance Committee as reflected in the attached letters which became integral part of this resolution.

2.3 That, disbursement of appropriation shall be guided by existing rules and regulations of Commission on Audit and all other government agencies,


