**RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH THRU SECRETARY FRANCISCO T. DUQUE III TO GRANT TWO (2) UNITS OF AMBULANCE TO BULALACAO, ORIENTAL MINDORO**

"WHEREAS, pursuant to Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

"WHEREAS, the Municipality of Bulalacao is a 3<sup>rd</sup> class municipality located at the southernmost tip of the Province of Oriental Mindoro and according to the 2015 census it has a population of 39, 107 people where a huge number of it are indigent, it is deficient of hospital and medical facilities that can support and provide medical services to its people;

"WHEREAS, an ambulance is a medically equipped vehicle which transports patients to treatment facilities and used to respond to medical emergencies; it can rapidly transport paramedics and other first responders to the scene, carry equipment for administering emergency care and transport patients to hospitals or other definitive care;


"WHEREAS, the Municipality of Bulalacao is the farthest municipality from the City proper which is Calapan, in times of emergencies and/or life-and-death situations, it is unfortunate that because of the limited unit of ambulance the ailing patients of this municipality are having a hard time in travelling to the city that has a better hospital and medical services to ensure their medical attention,

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Department of Health thru Secretary Francisco T. Duque III to grant two (2) units of ambulance to Bulalacao, Oriental Mindoro.




