RESOLUTION NO. 20-03-219

REQUESTING THE NATIONAL COMMISSION ON INDIGENOUS PEOPLE (NCIP) TO WITHHOLD ANY ACTION ON THE CERTIFICATE OF ANCESTRAL DOMAIN TITLE (CADT) APPLICATION COVERING BULALACAO, ORIENTAL MINDORO UNTIL A WIN-WIN AGREEMENT HAS BEEN REACHED BY AND BETWEEN THE LOCAL GOVERNMENT UNIT OF BULALACAO AND THE HANUNUO MANGYAN

"WHEREAS, on September 9, 2019, the Sangguniang Bayan of Bulalacao, Oriental Mindoro passed Resolution No. 19-09-134 entitled "Earnestly requesting President Rodrigo Roa Duterte to facilitate the conversion of certain forestal areas into Alienable and Disposable Lands particularly Barangays Cabugao, Nasucob, Benli, Milagrosa, San Roque, San Juan, San Isidro and Bagong Sikat, all of the Municipality of Bulalacao, Province of Oriental Mindoro";

"WHEREAS, however, on November 27, 2019, PHADAG Inc. or the Pinagkausahan Hanunuo sa Daga Ginurang expressed strong objection to the above resolution as reflected in the letter sent to the President of the Republic of the Philippines, the Honorable Rodrigo Roa Duterte and to the Office of the Governor, Province of Oriental Mindoro saying that the forestal lands mentioned in the resolution of the Sangguniang Bayan belongs to "lupang ninuno" and that they have a pending application for titling;

"WHEREAS, the Sangguniang Bayan Resolution was passed because it believes that proper classification, management and utilization of lands of the public domain to maximize its productivity is necessary in order to meet the demands of the increasing population including the social and economic benefits of our hanunuo mangyan brothers and sisters;


"WHEREAS, to achieve a win-win solution to the conflicting opinions shown above, the Sangguniang Bayan of Bulalacao is doing its very best to arrive into a mutual agreement beneficial for both parties by calling a meeting with PHADAG and other concerned agencies to resolve the issues immediately; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the National Commission on Indigenous People (NCIP) to withhold any action on the Certificate of Ancestral Domain Title (CADT) application covering Bulalacao, Oriental Mindoro until a win-win agreement has been reached by and between the Local Government Unit of Bulalacao and the hanunuo mangyan;
