RESOLUTION REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THRU SECRETARY EDUARDO AÑO TO GRANT ADDITIONAL FUND IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (PHP150,000,000.00) FOR THE COMPLETION OF SINARAYAN-BAGACAY-SAN VICENTE-SAN JUAN-BANGKAL-SAN ROQUE PROVINCIAL ROAD LOCATED IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO UNDER THE CONDITIONAL MATCHING GRANT TO PROVINCES (CMGP) PROGRAM

“WHEREAS, pursuant to Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

“WHEREAS, the Department of Interior and Local Government (DILG) is the executive department responsible for promoting peace and order, ensuring public safety, and strengthening the capability of local government units to effectively deliver basic services to the citizenry;

“WHEREAS, the Conditional Matching Grant to Provinces (CGMP) for Road Repair, Rehabilitation, and Improvement is a partnership program between the Department of the Interior and Local Government (DILG) and Department of Budget and Management (DBM) for Provincial Local Government Units in response to the needed infrastructure support, as well as reforms in local roads management (LRM) and public financial management (PFM), it designed to contribute to a robust and competitive national economy, it also aims to improve the state of local roads and connect these to national road networks, through this, it will enhance local and regional productivity easing out value chain bottlenecks in agriculture, tourism and manufacturing;

"WHEREAS, pursuant to Executive Order No. 370 the Municipality of Bulalacao is considered as a 3rd class municipality; it is located at the southernmost tip of the Province of Oriental Mindoro and according to the 2015 census it has population of 39, 109 people where a large number of it are necessitous including the indigenous people called Hanunuo-Mangyans;

"WHEREAS, the Local Government Unit of Bulalacao is constructing the Sinarayan-Bagacay-San Vicente-San Juan-Bangkal-San Roque Provincial Road, and is asking the appropriation of additional fund in the amount of One Hundred Fifty Million Pesos (PhP 150,000,000.00) for the completion of concreting works of the said provincial road;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Department of Interior and Local Government (DILG) thru Secretary Eduardo Eduardo Año to grant additional fund in the amount of One Hundred Fifty Million Pesos (PhP 150,000,000.00) for the completion of Sinarayan-Bagacay-San Vicente-San Juan-Bangkal-San Roque Provincial Road located in the Municipality of Bulalacao, Province of Oriental Mindoro under the Conditional Grant Matching Grant to Provinces (CMGP) Program.
