**RESOLUTION RECOMMENDING TO THE MUNICIPAL MAYOR THE APPROVAL OF THE CONVERSION OF SAN FRANCISCO-SAN ISIDRO-CABUGAO BARANGAY ROAD INTO SAN FRANCISCO-SAN ISIDRO-CABUGAO PROVINCIAL ROAD IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**“WHEREAS**, Provincial Ordinance No. 66-2017, series of 2017 sets certain guidelines and requirements in the conversion of barangay roads into provincial roads;

**“WHEREAS**, San Francisco-San Isidro-Cabugao Barangay Road starting from National Highway is passable for at least five (5) years connecting three (3) barangay proper within the territorial boundaries of the province;

**“WHEREAS**, that road is traversing Barangays San Francisco, San Isidro and Cabugao all of which are engaged in agriculture and fishing industries and as such an all-weather road network is indispensable to support economic activities, delivery of social services and the attainment and maintenance of peace and order, development and progress;

**“WHEREAS**, taking into consideration the guidelines enumerated in Provincial Ordinance No. 66-2017, and the submitted Resolusyon Blg. 008-2018 of Barangay San Francisco, the barangay mentioned above is recommended to be converted into a provincial road; Now, therefore, be it




