**RESOLUTION REQUESTING THE SANGGUNIANG BAYAN OF
MAGSAYSAY, OCCIDENTAL MINDORO TO HOLD A JOINT SESSION WITH
SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO TO
DISCUSS THE TERRITORIAL JURISDICTION OVER SITIO BAGONG SILANG**

"WHEREAS, the Cadastral Act provides for the efficient management of land and the protection of ownership by registering the information concerning land in a cadastral record and managing it after conducting its survey and measurement and by prescribing the matters related to the furnishing of registered information;


"WHEREAS, the Municipal Assessor Regin T. Dimaano of Bulalacao, Province of Oriental Mindoro verified thru 2015 Approved Cadastral Survey that the Sitio Bagong Silang is within the boundary of Barangay San Isidro, Bulalacao, Province of Oriental Mindoro and also as per the Sangguniang Barangay of San Isidro most of the people in Sitio Bagong Silang are registered in Oriental Mindoro;

"WHEREAS, the people living in Sitio Bagong Silang are uncertain on which Province they belong to, it is proper for them to know which rules and regulations they should follow, it is rightful that they should also experience the benefits and advantages of their legitimate Province; to have a congruous meeting between the Sangguniang Bayan of Magsaysay, Occidental Mindoro and Sangguniang Bayan of Bulalacao, Oriental Mindoro will be favorable for the people of Sitio Bagong Silang to clear the issue of their territorial jurisdiction, Now, therefore be it;


RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Sangguniang Bayan of Magsaysay, Occidental Mindoro to hold a joint session with the Sangguniang Bayan of Bulalacao, Oriental Mindoro to discuss territorial jurisdiction over Sitio Bagong Silang.






