"WHEREAS, subject Appropriation Ordinance reveals substantial compliance with the same law and its Implementing Rules and Regulations with the following recommendations to wit:











1. That, the grant of Mid-year bonus shall comply with the provisions of DBM Budget Circular No. 2017-2;

3. That, the Sangguniang Barangay of Poblacion, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith and notify this Body of actions taken there on;
4. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Poblacion in connection with the implementation of said appropriation ordinance; Now, therefore, be it




