RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 1 CY 2018 OF BARANGAY MAUJAO AMOUNTING TO ONE HUNDRED TWENTY ONE THOUSAND EIGHT HUNDRED TWENTY FOUR PESOS AND NINETY ONE CENTAVOS (PHP121,824.91) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 01-2018 DATED JANUARY 9, 2018

"RESOLVED AS IT IS HEREBY RESOLVED To: Approve Supplemental Budget No.1 CY 2018 of Barangay Maujao amounting to One Hundred Twenty One Thousand Eight Hundred Twenty Four Pesos and Ninety One Centavos (PhP121,824.91) passed under Sangguniang Barangay Appropriation Ordinance No. 01-2018 dated January 9, 2018; with the following recommendations, to wit:

1. That, the procurement of supplies and materials is in accordance with RA 9184 (Government Procurement Reform Act);
2. That, the disbursement of fund shall be in accordance with COA Rules and Regulations;
3. That, the Sangguniang Barangay of Maujao, Bulalacao, Oriental Mindoro is likewise advise to strictly follow the recommendations of the Local Finance Committee as reflected in the review letter attached herewith;
4. That, compliance with all existing and applicable laws, rules and regulations shall be the sole responsibility of the Sangguniang Barangay of Maujao in connection with the implementation of said appropriation ordinance;


