“WHEREAS, Ms. Cantos graduated with the degree in Bachelor of Science in Nursing and Master in Social Work specialized in Health Care Practice. In 2013, she was appointed as Social Welfare Officer I under the Municipal Social Welfare and Development Office, LGU Bulalacao at the same time designated as Officer-In-Charge of the office until her appointment to the position of the Municipal Social Welfare and Development Office;




