“WHEREAS, Sewage Treatment is the process of removing contaminants from municipal wastewater, containing mainly of household sewage plus some industrial wastewater. Physical, chemical and biological processes are used to remove contaminants and produce treated wastewater that is safe enough for release into the environment;

“WHEREAS, the construction of a Sewage Treatment Plant (STP) ensure that the municipality could deal effectively with domestic wastewater, helping them enhance sanitation in town and city while minimizing adverse environmental impact caused by improper water discharge;
