**AUTHORIZING THE MUNICIPAL MAYOR TO REPRESENT THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO ENTER INTO A CONTRACT OF SERVICE WITH MISS MYLEEN M. FAMINIALAGAO ENGAGING HER SERVICES AS PART-TIME FACULTY IN MINDORO STATE UNIVERSITY-BONGABONG CAMPUS-BULALACAO EXTENSION CLASS WITH AN HOURLY RATE OF PHP138.92 AS HONORARIUM FOR SERVICES RENDERED SUBJECT TO A "NO WORK NO PAY RULE" AND SUCH OTHER TERMS AND CONDITIONS AS MAY BE AGREED UPON BY BOTH PARTIES**

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Authorize the Municipal Mayor, Honorable Ernilo C.
