TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF PROTECTION  
DIKE AT KABURAYAN RIVER IN BARANGAY POBLACION, BULALACAO,

**“WHEREAS**, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions;

**“WHEREAS**, Bulalacao, a 3<sup>rd</sup> class municipality with a population of 44,366 based on 2020 census, is located at the southernmost tip of the province, is enclosed by Bulalacao Bay and Tablas Strait, and has 8 coastal barangay out of 15, one of which is Barangay Poblacion;

“WHEREAS, because of its location and climate type, Bulalacao is at high risk of weather disturbances and typhoons which causes flooding, storm surges and other damages that affects both agricultural and aquaculture industries, and the safety of the people;

“WHEREAS, the part of Kaburayan River situated at the entryway of Sitio Tabuk in Barangay Poblacion has no protection dike that can protect its residents from danger caused by strong storm surge;


“WHEREAS, the provision of protection dike in the said area of Kaburayan River would not only be beneficial to its residents but it would also support in upholding the structural integrity of public facilities and utilities of the municipality as a whole; Now, therefore, be it...






