RESOLUTION REQUESTING HIS EXCELLENCY FERDINAND R. MARCOS, JR., PRESIDENT, REPUBLIC OF THE PHILIPPINES TO FAVORABLY ESTABLISH THE REGIONAL DIABETES AND HYPERTENSION SPECIALTY CARE CENTER OF MIMAROPA REGION IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, Section 2 of Republic Act No. 11959 better known as the "Regional Specialty Centers Act" declares that the State shall adopt an integrated and comprehensive approach to health development by providing specialized health services to the general public through the establishment and institutionalization of specialty healthcare centers in all regions of the Philippines;

"WHEREAS, the said Act is a consolidation of Senate Bill No. 2212 and House Bill No. 7751 whose report of conference committee hearing was adopted by both the Senate and House of Representatives on May 31, 2023 and was then approved by His Excellency President Ferdinand R. Marcos on August 24, 2023, it aims to establish and institutionalize healthcare centers in every region that will ensure accessible and affordable healthcare services for all;

"WHEREAS, the Municipality of Bulalacao is one of the progressing municipalities in the Province of Oriental Mindoro, it is fast-approaching to be the agro-eco-tourism hub of the said province, and because of its midpoint location and operation of its Bulalacao RORO Port, it is being strategically accessible to all provinces in MIMAROPA Region;

"WHEREAS, having a paramount objective to uplift the general health condition of the people, the Local Government Unit of Bulalacao focuses in providing better health facilities and services, hence, it enthusiastically advancing to establish the Regional Diabetes and Hypertension Specialty Care Center of MIMAROPA Region within the municipality that will primarily cater eye care services, diabetes and hypertension services, and also offer other specialty care services to all the citizens of the region;

"WHEREAS, the Sangguniang Bayan of Bulalacao believes that it is best to establish the Regional Diabetes and Hypertension Specialty Care Center of MIMAROPA in this municipality for many advantageous reasons, thus, it would give utmost support to affirmatively provide convenient and efficient medical services to all the provinces of MIMAROPA Region; Now, therefore, be it...
