“WHEREAS, Bulalacao, a 3<sup>rd</sup> class municipality with a population of 44,366 based on 2020 census, has 15 barangays and total agricultural land area of 10,325.80 hectares with 6,016 registered individuals employed in the agricultural sector;


"WHEREAS, Bulalacao has a tropical climate type conducive to planting of staple crops such as rice and corn including garlic, onions and varieties of vegetables and fruits transported to Manila and nearby provinces;


"WHEREAS, the provision of solar dryer is essential to the rice industry of the said municipality as it can be used in post harvesting, it is a machine used for removing water from wet grains by forcing either ambient air or heated air through the grain bulk that can be operational through solar energy which are very conducive to the farmers of Bulalacao as it is continuously experiencing massive brownouts and power interruptions; Now, therefore, be it...


