RESOLUTION NO. 21-01-019

RESOLUTION REQUESTING THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) THRU SECRETARY FORTUNATO DELA PEÑA TO EXTEND TECHNICAL, FINANCIAL AND TECHNOLOGICAL ASSISTANCE TO THE LOCAL GOVERNMENT UNIT OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN ESTABLISHING WOOD AND BAMBOO PLANK AND PARQUET PROCESSING, AND MANUFACTURING PLANT

"WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

"WHEREAS, the Department of Science and Technology (DOST) is the premiere science and technology body in the Philippines charged with the twin mandate of providing central direction, leadership and coordination of all scientific and technological activities, and of formulating policies, programs and projects to support national development;

"WHEREAS, pursuant to Executive Order No. 370 the Municipality of Bulalacao is considered as a 3rd class municipality hounded with financial constraints, it is located at the southernmost tip of the Province of Oriental Mindoro and according to the 2015 census it has a population of 39,107 people where almost 25 percent of it are indigenous people called Hanunuo-Mangyans;

“WHEREAS, the establishment of programs like wood and bamboo plank and parquet processing, and manufacturing plant in this municipality would not only provide additional income to the municipal government but more importantly these would support Bulalacaonons to have a prolific and righteous livelihood especially in this pandemic time where work opportunities are being limited;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Department of Science and Technology (DOST) thru Secretary Fortunato dela Peña to extend technical, financial and technological assistance to the Local Government Unit of Bulalacao, Province of Oriental Mindoro in establishing wood and bamboo plank and parquet processing, and manufacturing plant.
