RESOLUTION NO. 33

RESOLUTION IN THE MATTER OF REQUESTING THE PROVINCIAL COMMANDER OF
ORIENTAL MINDORO, THRU THE PROVINCIAL BOARD OF SAID PROVINCE, THAT
PHILIPPINE CONSTABULARY (PC) CONTROL IN THE MUNICIPALITY OF SAN PEDRO,
ORIENTAL MINDORO BE LIFTED AND/OR DETACHED:

AWARE, that reports directly receive from all barrio Captains of
San Pedro, Oriental Mindoro, peace and order has been maintained and
restored unlike of some previous years, that peace and order has not
been maintained due to some troubles made by those recalcitrants and
dissidents; and

REALIZING, that Philippine Constabulary (PC) control in this Mu-
nicipality have greatly reduced, suppressed, diminished all sort of
troubles that have been arising throughout and within this Municipa-
lity, the Police Force Agency who are also peace officers, could
handle and maintain peace and order in lieu of Philippine Constabu-
lary (PC) control if lifted; and

CONSIDERING, the facts that the lifting of Philippine Constabulary
(PC) control in this Municipality will reduce the tranquility of
peace and order, the essence of this resolution is to request the
Provincial Commander of the Province, that a Detachment of Philippine
Constabulary be stationed permanently at San Pedro, Oriental Mindoro
in order to cope with the job in assisting, helping and securing
the Police Force Agency in suppressing, subduing any lawless elements
that may be happened in case of emergency and incidental cases; and

On motion of Councillor Modesto Macawag and duly seconded by Coun-
ciller Josclic Gado,

NOW, THEREFORE, this body, the Municipal Council of San Pedro,
Oriental Mindoro, hereby requests the Provincial Commander of Oriental
Mindoro thru the Provincial Board of said Province, that Philippine
Constabulary (PC) control be lifted and/or detached, in order that
Police Force Agency of this Municipality be given chance to handle
handle and exercise their daily functions for maintaining peace and
order; and

RESOLVED, that the Municipal Secretary is hereby
and authorized to send a copy of this resolution to His
Excellency, the President of the Philippines; the Chief of Staff of
the Philippine Constabulary; the Commissioner of the Police Commission
and the Provincial Commissioner of Oriental Mindoro for their immediate
action and consideration.
