VILLAS WITH MISS JANETTE CANSING SERRANO, CHAIRPERSON, NATIONAL COMMISSION ON INDIGENOUS PEOPLE (NCIP) FOR THE DIRECT APPLICATION OF THE HANUNUO MANGYANS FOR THE ISSUANCE OF CERTIFICATE OF ANCESTRAL DOMAIN TITLE (CADT) OR CERTIFICATE OF ANCESTRAL LAND TITLE (CALT)


