SPECIAL ORDINANCE NO. 08-05-73

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH MISS JANETTE CANSING SERRANO, CHAIRPERSON, NATIONAL COMMISSION ON INDIGENOUS PEOPLE (NCIP) FOR THE DIRECT APPLICATION OF THE HANUNUO MANGYANS FOR THE ISSUANCE OF CERTIFICATE OF ANCESTRAL DOMAIN TITLE (CADT) OR CERTIFICATE OF ANCESTRAL LAND TITLE (CALT)

"WHEREAS, the National Commission on Indigenous People (NCIP) is mandated to recognize, promote and protect the rights of ICCs/IPs to their ancestral domain/land through the process of identification, delineation and recognition of their claim through the issuance of corresponding Certificate of Ancestral Domain Title (CADT) or Certificate of Ancestral Land Title (CALT) which shall be registered with the Register of Deeds;

"WHEREAS, hanunuo mangyan tribes of Mansalay and Bulalacao and certain parts of Roxas expressed their interests to apply and subsequently be awarded with the CADT after so long a time for their benefits and the next generation ahead of them;

"WHEREAS, in order to fast track the processing of the ancestral domain claim of ICCs/IPs, the hanunuo mangyan tribes has sought the assistance of the NCIP and the Local Government Unit concerned by allocating the necessary appropriation thereof;

NOW, THEREFORE, UPON MOTION of Councilor Eduardo C. Aceron jointly seconded by Councilors Gideon B. Abuel and Ramon G. Magbanua.

SECTION 1. The Municipal Mayor, Honorable Ernilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with Miss Janette Cansing Serrano, Chairperson, National Commission on Indigenous People (NCIP) for the direct application of the hanunuo mangyan for the issuance of Certificate of Ancestral Domain Title (CADT) or Certificate of Ancestral Land Title (CALT);

SEC. 2. This Special Ordinance shall take effect immediately.

ENACTED this 12th day of May, 2008, Bulalacao, Oriental Mindoro.



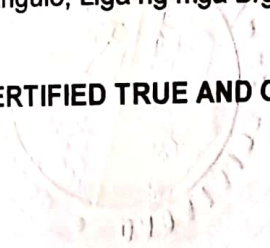


