
**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The Municipal Mayor, Engr. Emilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Honorable Arthur C. Yap, Secretary, Department of Agriculture (DA) for the grant of Ten Million Pesos (Php10M) of the latter to the former to be used for the construction/rehabilitation of Sitio F.F. Cruz-Sitio Napisian, Barangay Cambunang-Sitio Banaba, Barangay Benli Farm to Market Road, all of the Municipality of Bulalacao, Province of Oriental Mindoro.


